HISTORY



1993

Establishment of the first freight-forwarding company in the port of Novorossiysk -OOO Delo. Establishment of the line agency Forcon that laid foundation for RUSCON Group - a pioneer of container transportation in Novorossiysk.

1997

Foundation of ZAO Transport Corporation, a rail freight-forwarding company.

1999

Start of the first RUSCON container train from Novorossiysk – Moscow.

2002

Greenfield construction and start of the specialized container terminal OOO NUTEP in the south-eastern cargo area of Novorossiysk port.

RUSCON enters the St. Petersburg market for freight-forwarding and cargo transportation.

2003

RUSCON invests in the development of inland terminals in the south of Russia.

2007

Delo Group acquires Kombinat Stroykomplekt (KSK), adjacent to NUTEP, in order to start construction of the modern grain terminal, ZAO KSK.

Transport Corporation expands its geography and offers integrated transportation and railway freight forwarding services across Russia and the CIS.

Technical modernization of NUTEP with throughput capacities increased to 350 thousa TEUs. Delo Group consolidates 100% of NUTE

RUSCON invests in the development of inland container terminals in the Moscow region and north-west of Russia.

Construction of inland oil-products terminal an the port oil-products transhipment complex.

Launch of NNK oil products transhipment complex with throughput capacity of 400 thousand tonnes per year.

Completion of the first development stage of K Grain Terminal: capacity increased to two million tonnes of grain per year.












Revenue, mIn USD








The volume of rail container transportation, thous. TEUs



Container handling volume at the terminals, thous. TEUs








